Objectifs (et/ou acquis d'apprentissages spécifiques)

At the end of the course, students will be able to:

- > Model a problem with the tools of industry economics and microeconomics
- > Establish links between the concepts covered in class and economic actuality
- > Understand how the tools can highlight situations and and how to fix them

Méthodes d'enseignement et activités d'apprentissages

Each lecture starts with a discussion on a newspaper article related to microeconomics or industrial organization, for instance, a recent antitrust case (like eBooks) that is chosen and introduced by one of the students. Students choose early in the course a topic and a paper that they present during the class. The instructor presents before or after this student presentation other material related to the topic (e.g., advertising, bundling).
