Job description

This vacancy is for a lecturer-researcher specialised in urban planning and land use law. The position involves teaching a series of courses in the Master's programmes in architecture (Brussels) and urban planning (Charleroi), as well as participating in the research activities of the ULB Faculty of Architecture's laboratories, in close collaboration with the Faculty of Law.

Courses included in the position:

- **Urban planning and socio-ecological transition law:** 24 hours, compulsory course for the Master's degree in urban planning in Charleroi.
- **Urban planning law:** 24 hours, compulsory course for the Master's degree in architecture (approximately 250 students). This course will also be open as an optional course to students of the Master's degree in law.
- **Supervision of dissertations.**
- **Course to be determined:** 24 hours, optional course to be created in the Master's degree in architecture at the ULB (new course), in collaboration with the Faculty of Law.

Qualifications required :

PhD in law, with specialisation in Belgian public law, urban planning law or environmental law.

If the candidate does not hold a PhD, they must hold a master's degree in the above-mentioned fields and must demonstrate significant professional experience relevant to the courses to be taught and an appetite for research.

Skills required

- Teaching experience in the subjects covered by the teaching load.
- Expertise in Belgian domestic law, demonstrated either by qualifications or previous research, including through professional experience.
- Excellent command of French (level C1) and passive command of English and Dutch. Active knowledge of one of these two languages is an asset (level B2).

- A scientific background and significant research experience, demonstrated by a doctoral thesis in legal sciences, the writing of scientific articles, the supervision of applied research or the organisation of scientific events, are an asset.

This template structures your application by including the following elements:

- A cover letter;
- An academic portfolio of no more than 6 pages, including a report on any previous teaching experience and a teaching plan for the proposed courses, including how they fit into the programme and specifying the teaching and assessment methods envisaged.
- A research portfolio of no more than four pages, including a description of past research activities (or equivalent activities in the case of a non-academic background) and a research project specifying the topics envisaged, avenues for development, and commitment to the University's research activities.
- The thesis report written by the jury after the defence (if available).
- The names and contact email addresses of three referees who may be contacted by the bodies responsible for assessing the applications, ensuring gender balance. These individuals must not have any conflict of interest due to family or emotional ties.
- If available, three publications representative of your profile, accompanied by a note justifying the choice of these three publications and their contribution to the subject covered by the position.

Incomplete applications or applications that do not use the template provided will not be examined by the selection committee.
