

## PART TIME ACADEMIC POSITION INTERIMAIRE IN COMPETITION LAW (MONS)

### Job description

The Faculty of Law and Criminology at ULB is offering an interim 10% lecturer position to teach the course 'EU Competition Law' (DROIC5183) in the academic year 2026-2027. This course comprises 24 hours of teaching.

This course is part of a European Law module offered to students enrolled in the 'Business Law' specialisation of the Master's in Law programme offered by the University of Mons. It is taught in English and takes place in the second semester (between February and May), with assessment sessions in June and August.

The holder will be called upon to supervise or assess final year projects within the Master's degree in Law. The holder of the position will be attached to the Faculty of Law and Criminology at ULB and will be invited to collaborate with the School of Law at the University of Mons-ULB.

### Educational and scientific objectives:

The course aims to provide a general education in European competition law. The course is expected to cover the following topics: the place of competition policy in the European integration project; the institutional and procedural aspects of competition law, including private enforcement; as well as the matters covered by Articles 101 and 102 TFEU, and State aid law, but also more recent texts such as the Digital Services Act (DSA) or the Foreign Subsidies Regulation.

The holder of the position is expected to give their teaching a resolutely contemporary dimension, drawing on current debates and cases. Particular attention will be paid to the digital sector. While the course remains a law course, the holder is expected to incorporate considerations from other disciplines, starting with economics, into their teaching to ensure a holistic approach to competition policy.

During the second semester, students can deepen their knowledge of European economic law, with courses dedicated to internal market law (DROIC1582) and European private law (DROIC1581). The holder of the position is invited to consider the subjects covered by these courses and to ensure good coordination with the other holders.

As this is a course offered in the final year of the Master's programme, the teaching method must be interactive, based in particular on the discussion of relevant decisions and judgments, and other preparatory readings.

## Qualifications required

Hold a Master's degree with 120 credits in law and preferably a PhD in Law.

## Skills required

- Excellent knowledge of European competition law and its practical implementation.
- A level of English sufficient to teach and assess work in this language (C1).
- An established reputation in the field of competition law, demonstrated in particular by high-quality academic publications in these subjects and/or relevant professional experience.

The following would be considered an advantage:

- An advanced Master's degree in European law and/or competition law
- Teaching experience at university or college level
- Experience in the practice of European competition law, acquired at the Bar, in the private sector or within the institutions.
- Skills in another relevant discipline, such as economics

- the names and e-mail addresses of five referees (respecting the gender balance) who may be contacted by those in charge of evaluating applications. These referees should not have conflicts of interest because of family or emotional ties.

Incomplete applications or applications that do not use the template provided will not be examined by the selection committee.
